



BOWLING WITH THE BUNNY


Held April 2nd, 2023

UAW 2023 Special Bargaining Convention Resolutions Conference March 27-29 Detroit, Michigan

Again, we want to Thank the membership for



electing us Delegate's to the 38th UAW Constitutional Convention, and now we had the privilege of representing our Local 1166 at the 2023 Special Bargaining Convention Resolutions in Detroit, Michigan on March 27th-29th. We had a few guest speakers including Gary Peters, Michigan Senator, Debbie Dingel, 12th District Congresswoman, Gretchen Whitmer, Michigan Governor.

On Saturday, March 25, 2023, at 12 noon our UAW 1166 Brother Shawn Fain was sworn in as the new UAW President. We had the privilege of having dinner with the new UAW President Shawn Fain and got a picture of the members of UAW 1166. Picture is below.



During our 3 days of meetings resolution topics in general were brought to the floor for a vote to accept or change. There are thousands of resolutions that have been submitted and have been turned over to the Nation Negotiation teams. The main topic had many sub

-titles, but main topics were under Economic Issues, Non-Economic Issues, Job Security, Other Economic and Non-Economic issues.

Again, we want to thank our membership for voting us Delegates and the opportunity to represent the membership of 1166. We also just want to remind everyone that September 2023 is National Contract time. If you're interested in looking at any books, we got at convention please let us know and we will share any information provided to us for memberships information.

Special Bargaining Convention Report:

First let me thank you, the membership, for electing me as an Alternate Delegate. and I am grateful for the opportunity to serve and represent the membership her at 1166

Day One of the Convention:

The new Executive Board was introduced. UAW President, Shawn Fain, gave a speech where he talked about unity.

“We’re here to come together to ready ourselves for the war against our one and only true enemy: multi-billion dollar corporations and employers that refuse to give our members their fair share.”

There were a few guest speakers including Michigan Senator Gary Peters, Senator Debbie Stabenow and UNIFOR President Lana Payne.

Delegates debated a COLA resolution at length with passionate speakers on both sides. Those speaking in favor of the resolution welcomed more comprehensive language on a top ranking issue for our membership. Those speaking against felt the language was too specific and could ‘tie our bargainers hands.’ While the resolution on COLA failed the omnibus resolution passed at the end of the convention included language on COLA. UAWs intention is to, 'Secure wage increases and other compensation that ensures earnings keep pace with or exceed inflation and productivity increases, whether through general wage increases, bonuses, profit-sharing, COLA(Cost of Living Adjustments) or other means.

Day Two of the Convention:

Delegates discussed: wages, profit-sharing, healthcare, work schedules, health and safety, organizing higher education, and support for veterans. Michigan Governor Gretchen Whitmer was a guest speaker and spoke on Michigan being the first state to overturn Right to Work.

Belvedere was a central issue for UAW VP Rich Boyer playing a video for the delegates called ‘We are Belvedere ’ VP Boyer continued the message of unity

telling the delegates:

“I’m going to make one commitment to everybody in this room. If you’re in trouble, we’re coming. We’re coming to your side. We’re going to walk the line with you. We’re going to do whatever we’ve got to do to make sure you survive.”

Day Three of the convention:

Delegates passed two resolutions that were pulled out of committee for debate. The first was one on honoring picket lines with language mirroring what Teamsters have; meaning, if bargained for, workers wouldn’t have to cross a picket line on their way to work and could refuse. The second was a Higher Ed resolution that was tabled from the day before and it passed with overwhelming support.

President Shawn Fain closed out the convention with a speech saying, ‘If we stand together, they will not break us. Our power is in our members. It is not who is up on this stage.’

Convention adjourned.

I want to add it was absolute honor to be an alternate Delegate and to get to attend this convention. It allowed me to learn and grow as a union member. Learning about procedural process of our union, learning about the things that our brothers and sisters in other unions are passionate about and want to speak about. I love the debate and to see the democratic process work. Whatever this year holds for us with the contract coming up remember we have one another and we have our solidarity. We hold the power, we control our futures and we are strong!!! Stand and demand our fair share and stand against corporate greed!!!

I wanted to report back to you all about the 2023 Community Service Committee Conference that I attended from April 16-21 at the Walter and May Reuther UAW Family Education Center also known as Black Lake. There were a total of 182 Community Service Committee delegates in attendance that week. That gave me a chance to do some much needed networking and get ideas from people of all different backgrounds and union companies.

We had quite a few key-note speakers that week. Ava Barbour from legal department on “Ethic Issues”, Gertrude Hahn on “Strike Assistance & Preparations”, Bob Cramer the United Way Liaison for Michigan, Bill Eaddy on “Peer to Peer Support”, Tracey Chew from CNH Local 807 who spoke about her 264-day strike. I



may be a little biased, but my favorite speaker was UAW President Shawn Fain. He spoke on the fact that corporate is not our friend nor is he playing around with them. He showed a couple clips from the 2011 movie “Moneyball” to get his point across in another way. He gave a wonderful speech, and I was proud to know that he came from our very own little Local with the big hearts 1166!! The fact that he carries his grandfather’s paycheck stubs from Chrysler lets me know he will stay grounded, and humble. Not letting this position go to his head. He took his time and spoke to everyone who wanted to shake his hand and snap a picture with him.

The classes that I took were over Community Service Committee history, Community Mobilization, Disaster Preparedness, Layoffs, Closings, and Strikes as well as creating a one-year strategic plan for our local Community Service Committee. It was definitely information overload, but I have all my books and notes to keep me knowledgeable of it all. I understand that dues dollars pay for these conferences and events, so I hope to serve you


