As I look back on all the things that I have experienced in this year of my life, the fact that I had blockages that no one could find, for three months we looked and looked, and finally the cardiologist and a heart cath found it, to the point that a week later, I stand in the surgeon's office, him explaining to me that I should have never went home from the hospital after the heart cath on April 26th. He would be willing to do the surgery the next day on Saturday, if I was willing to do it the very next day. Of course I was.

On May 4th, I found myself being loaded onto an operating table at 8:30 in the morning. They were about to perform a triple by-pass by means of an open-heart surgery. I had never had any sicknesses like that in my life, and I was terribly afraid. Testing my faith and my knowledge of who God really is and if I was worthy of Him.

As I woke in the hospital, surrounded by a team of doctors and nurses that will be ever etched in my mind, as a team of diverse people that work together in unison, despite their differences in nationalities, in races, in opinions, in faiths, and in beliefs. Working like a well-orchestrated team.

I think back at being chaplain since 2008. How fortunate I have been to be a part of so many people's sufferings and losses. I think back, and I also remember that it was not myself that was going through these things. When it was me, for some reason, it became crystal clear to me the importance of this chaplain's committee. I know many people who have gone through a lot worse things than this.

You see, I have strived my best at times to be the person that God has called me to be in this place, called the Kokomo Casting Plant. I have served you many times, and with joy and with thanksgiving, that I have had the opportunity to do so. It is my calling in life, as one would say.

However, I was now the one on the other side of the bed. As soon as I became the patient, I realized how important it is to take each day as it comes and show up as best as I can. I am only human with lots of short comings and if I have ever offended you in my work as a chaplain, I am so very sorry. I would ask for you to forgive me.? It is an honor to serve in the workplace with all of you and I do not take lightly the responsibility I have to provide spiritual care for those in need, whatever that might be.

As I laid there in that hospital thinking about life ahead, I want to encourage each one of you that no matter what you are facing, no matter what you are going through, our God is strong and able and willing to walk through that with you.

My recovery is progressing very well and I hope to soon be back to work. I look forward to seeing all of you.

My career at Chrysler started in 2012 when I was hired and placed at the Kokomo Transmission Plant KTP. I was put in the 8 speed launch. It was the first time I had been in a manufacturing plant. Previously I worked property maintenance where I worked as a maintenance tech on residential rental properties. When there was a maintenance issue at a property, I would go there and fix it. Being in a factory was a whole new world. I met different people almost daily. I was in a production department, and it was a launch department. There were always issues with the machines since they were brand new; however when something went wrong with them, I was not supposed to do anything except ask for help and wait for someone else to fix it. I was not used to doing this since in my previous job I was the guy who was supposed to fix things. It took restraint on my part to watch things break and sit back and wait.

After a year and a half at Chrysler, I became a team leader. I was placed in 9 Speed as a launch team leader on C-Crew. It was a different department that I knew nothing about, and I was given 10 new hires who had been at the plant for less than a month. I was still basically a new hire myself. It was the blind leading the blind. However, I loved the challenge. I enjoyed everything including learning the machines, writing up the jobs, meeting the trades at the jobs, and learning what they were doing to fix the machines. I enjoyed learning the processes and teaching others. I was a team leader for a majority of my time spent at KTP.


When I became aware that a new list would be populating for the apprentice program, I jumped at the chance. I quickly took the three courses required to apply and passed which placed me on the list. When I passed, I was asked to choose my top 3 choices of trade. My first choice was electrician. I waited on the list around two years. When my time came to get into the program, I was offered electrician. I was very happy that I was offered my first choice. Then I read the second sentence on the letter stating I would be assigned to the Casting Plant. I was hesitant to start a new job in a new plant, and I was very unsure of what I should do. I knew electrician was the only trade I really wanted to pursue, but the idea of going to the casting plant was unnerving. I had been in two of the largest and highest demand departments at KTP and knew a lot about everything there. I had assumed I would be assigned electrician at KTP, and I could just hit the ground running since I had been writing up jobs and watching trades there for years. I decided I could not pass up the opportunity, so I accepted the position and signed the paperwork.



Prior to going to the Casting Plant, I had always been told that it's a dirty, hot, and dangerous plant. After working at the Casting Plant for over a year, I really don't agree with that stereotype. I do see the grease and grime, but I also see the people who sweep the floors daily in trim, and I see the people who pull up grates and clean out the troughs around the die cast machines. I watch as operators clean out the pits and use water hoses and squeegee's to clean the floors around their machines. I have been very impressed with how much people here care about their jobs and what they do. Yes, the machines and floors can be dirty here. I'm not implying they are white like next door, but there is really no way around it. However, people on every shift do their part to make it as good as it can be. The other thing that really impresses me is the people. It's a much smaller plant. KTP is a massive plant and part of a massive local. People transfer between plants all the time, so it's not uncommon to see new faces daily. I had no clue what to expect at first, but in my experience the people here and the trades have been great. Everyone is willing to help and teach someone who is willing to put forth the effort to be taught. The dangerous part in my opinion is mitigated by training and people taking the job seriously. Safety seems to be a lot higher priority here than other plants. I think people here are aware that these are dangerous machines and safety is a must.

Being an apprentice it is very overwhelming in the beginning. The journeymen warned me that initially I wouldn't understand a lot of the terminology and encouraged me to ask questions. They also told me that over time the words they use would start to mean something and everything would start to make more sense. They could not have been any more correct. Especially coming from a different plant, I had to learn all the names of all the parts of a die cast machine on top of trying to learn the new trade itself. It was very overwhelming at times. In the beginning, it was all coming at me so fast I felt like I was learning nothing. However week-to-week and especially month-to-month I realized I was starting to retain parts of the puzzle and the massive die cast machines started to seem a lot smaller. It went from being an unsurmountable task to fix anything on the machines to understanding that it's made up of small components. It really has been a great experience and I have enjoyed working with everyone from the operators to the journeymen to the other apprentices. I look back on it, and I am glad I was given the opportunity to join the Casting Plant. I would not change it if I had the chance to do it over.





If you or your spouse are enrolled in one of the FCA health plan's, you or she can take advantage of a 3D mammogram.

Why a 3D mammogram?

3D mammography can detect breast cancer up to 18 months earlier than traditional 2D screenings. It takes just a few minutes, and although there may be some slight pressure, the peace of mind is worth it. The mammogram may point to nothing at all, or to any of several problems that aren't even breast cancer — things like benign pain, a benign breast mass, breast cyst, mastitis or abscess — some of which simply ebb and flow with hormonal changes. But if yours points to a more serious problem, you can take comfort in knowing you've found it early and will soon be on the road to personalized treatment options.

- Screening appointments typically last for 20 minutes. Please make every effort to be on time for your appointment. If you are 10 or more minutes late, your appointment will be cancelled.
- You must bring your health insurance card(s) and driver's license or photo ID with you to your mammogram appointment. If your health insurance information is electronic, please bring a paper copy of your information with you to your appointment.
- Please wear a two-piece outfit.
- If you are wearing deodorant at the time of your appointment, you will be asked to wipe it off because deodorant distorts the images. Fresh deodorant will be provided.
